FULL COURSE INFORMATION

This course is a combination of online, self-directed learning and a live, virtual, interactive session with our Health & Safety trained events expert, Sarah Threlfall. The course consists of a total of approx. 6 hours learning time. 2 hours online, 3 hours live training and then 1 hour of assessment and reflection.

The virtual live session will be in small groups (max 20) and will include time for Q&A, discussions around the practical implications of the new legislation and situations specific to the attendees. Where possible, we will try to group people with similar roles or experience together although this is subject to availability.

You will hear from other specialists from across the industry including venues, leading agencies and mental wellbeing experts. We'll take regular, short breaks and encourage full participation from everyone throughout

Course Aims

To give you the skills, knowledge and tools to confidently organise professional and compliant COVID Secure events. You will be able to create COVID Secure events risk assessments and any other required documentation to help implement the measures in the assessment.

Course Objectives & Learning Outcomes

- Understand basic Health & Safety legislation and principals and how that relates to your responsibilities as an Event Organiser
- Apply knowledge of Health & Safety culture to ensure you design and deliver the best possible events within a COVID Secure framework
- Summarise the science behind the pandemic and the risk of transmission and understand the specific needs of a COVID Secure risk assessment
- Find and analyse all relevant government guidance, legislation and industry best practice guides that relate to planning COVID Secure events.
- Identify chances for, and evaluate the risk of, transmission of the virus and suggest control measures using a COVID Secure risk assessment template
- Relate to the potential risk to Mental Safety and explain measures to control the risk
- Develop a COVID Secure events risk assessment
- Appraise any live events which you run, against the risk assessment, and identify best practice to take forward including any improvements or changes
- Explain the need for and considerations when developing a COVID Secure event communication plan, monitoring documentations and review schedules
- State your responsibilities as an organiser regarding test and trace, RIDDOR and outbreak reporting and how that should be applied in real life event scenarios







FREQUENTLY ASKED QUESTIONS

How much is the course?

What if the law or guidelines change after I've finished my training?

We will release FREE additional training modules and update emails to cover any changes in the legislation. You will be notified by email of these complimentary sessions and can study them online as soon as they are released. We will send reminders for you to complete these but it is your responsibility to stay up to date with UK legislation and guidance post training.

How long will the course take?

Approximately 6 hours in total.

The online module is expected to take around 2 hours to complete including a short assessment. The live workshops are approximately 3 hours (depending on how involved the group are!) plus another hour of assessment and practical assignment follow up work.

How long will I be able to access the content?

What will I get out of the training?

A basic knowledge of the UK legislation (mainly focussed on England) and guidance for Health & Safety and risk assessments with specific attention to how this translates into planning COVID Secure events. You will get a rounded understanding of the whole process to enable you manage your own events safely in the future.

Who is the course for?

The training is relevant to anyone who is involved in running events of any size for any audience and in any capacity! Event planners, project managers, production managers, venue finders, venues, wedding planners, party organisers, account directors, managing directors, operations directors, PAs, EAs. If you are unsure, if the course will be suitable, we'd be happy to discuss your specific circumstances.

Will the content cover the arrangements in other countries?

We will discuss how the legislation differs in England, Wales, Scotland and Northern Ireland but will not cover any specifics outside of the UK. Obviously, the principles of COVID secure events and the starting approach to Health & Safety and risk assessments is the foundation you will need no matter where the event is held.

Will I receive a certificate?

Yes! Everyone who completes the online training, attends the live session and successfully passes the assessments will receive a certificate of completion. Unfortunately, the training is not accredited by IOSH as they have suspended accreditation since March so we are not permitted to issue an actual qualification.

What are the main benefits of this training format?

Unlike a purely online certification, our workshops will allow you time to fully explore the COVID Secure process in relation to your business, your specific events and your clients. Our Event Management expert, who is also trained in Health & Safety, will be able to advise you on the particular implications you need to focus on.

Do I need any previous Health & Safety training or experience?

No. The online modules cover the basics of Health & Safety and risk assessments and there will be plenty of opportunity to ask as many questions as you need to during the live sessions. We will also try to group you with people who have a similar level of knowledge or background in the workshop so that we can offer a bespoke experience.
